Subject: AADHAR number as UID number for registration of patients for treatment of cases of Hepatitis C cases under MMPHCRF in the Govt. Hospitals of the State

Vide these office orders, the following amendments are done to the SOPs (Standard Operating Procedures) of MMPHCRF (Mukh Mantri Punjab Hepatitis C Relief Fund) for treatment of cases of Hepatitis C in the designated Govt. Hospitals of the State.

1. AADHAR number shall be mandatory for registration of Hepatitis C cases under MMPHCRF. AADHAR number should replace the UID number being generated at present with immediate effect.

2. Only those patients can be initiated on treatment who have AADHAR number of the State of Punjab.

3. Those patients who have been diagnosed as a case of HCV but do not have AADHAR number should be advised to get AADHAR number for initiating the treatment for HCV under MMPHCRF.

4. Civil Surgeon of each district will review the implementation of MMPHCRF personally and will be responsible for compliance of these office orders and SOPs in the respective district.

These orders will come in force in the State with immediate effect.

Subject: AADHAR number as UID number for registration of patients for treatment of cases of Hepatitis C cases under MMPHCRF in the Govt. Hospitals of the State

Vide these office orders, the following amendments are done to the SOPs (Standard Operating Procedures) of MMPHCRF (Mukh Mantri Punjab Hepatitis C Relief Fund) for treatment of cases of Hepatitis C in the designated Govt. Hospitals of the State.

1. AADHAR number shall be mandatory for registration of Hepatitis C cases under MMPHCRF. AADHAR number should replace the UID number being generated at present with immediate effect.

2. Only those patients can be initiated on treatment who have AADHAR number of the State of Punjab.

3. Those patients who have been diagnosed as a case of HCV but do not have AADHAR number should be advised to get AADHAR number for initiating the treatment for HCV under MMPHCRF.

4. Civil Surgeon of each district will review the implementation of MMPHCRF personally and will be responsible for compliance of these office orders and SOPs in the respective district.

These orders will come in force in the State with immediate effect.
